
# One Riverfront Plaza sale is a plus for both Westbrook and Maine Med

Last month, Maine Medical Center became the new owner of One Riverfront Plaza in Westbrook. The six-story Class A office



building was originally developed by Tim Flannery as a build-to-suit corporate office for Disability RMS in April 2005. In 2006 Flannery sold the property to an investor, Pendleton Westbrook SPE.

The building is located on a half-acre parcel with virtually no on-site parking; however, as an economic incentive to its original development, the City of Westbrook agreed to build the adjacent 540-space parking garage.

DRMS leased the property until 2015, when attempts to renegotiate the lease's renewal clause could not be agreed upon. With the loss of the tenant, the owner did not satisfy the terms to its mortgage, and the property went into foreclosure.

Maine Medical Center became aware of the property's availability in early 2016. Their initial interest was a tenancy, but that changed as their appraisal due diligence lead them on a different course of action. Malone Commercial Brokers represented Maine Medical Center in its acquisition. MMC paid \$10,750,000 for the asset. The price in 2006 was \$23.5 million.

At 134,000 square feet, this is downtown Westbrook's largest office building. The property will house MMC's information services team and other administrative employees (400-500) who are currently spread across eight office locations.

"We believe this will increase our team's operating efficiencies and ultimately benefit our providers, nurses and the patients who benefit from their care," said Marcy Dunn,

senior vice president and chief information officer for MMC and MaineHealth.

City officials had expressed hope that a locally-based company would take over the entire building. "Their purchase and use of this location on the river will be key to the ongoing development of our downtown," Westbrook Mayor Mike Sanphy said.

Mark and Joe Malone, along with Jenn Small who represented MMC, worked on the project with the buyers for several months. NAI The Dunham Group's Charlie Craig and NAI Hunneman represented the seller, One Riverfront Plaza Holdings LLC.
